

LEGAL NOTICE FOR EXPORT CONTROL

Please note: The term "Goods" as used hereinafter shall be interpreted to include hardware, software, transfer of technology as well the corresponding documentation, regardless of the mode of provision.

The export or the technology transfer of goods, marked in the respective order document with an export list number, are subject to either the regulations of the Foreign Trade Law of the Federal Republic of Germany or, as in the case of cross-border trade in goods, the export regulations of the European Union. The provision of controlled goods from the territory of the European Union is subject to a valid export permit issued by the Federal Office of Economics and Export Control (BAFA) or local authorities from the EU state from which the goods are exported. A requirement for approval may arise from the technical specification, the material quality of goods, as well as the intended end-use.

Please note that in case of direct or indirect further distribution, the responsibility and the export control for the intended export shall be borne and carried out solely by the respective principal.

SINGULUS TECHNOLOGIES AG will refrain from carrying out deliveries if the known location of end-use, end-user or purpose is deemed critical. Required end-user documents and / or declarations which are necessary for the internal order examination must be provided by the client upon request of the export control before the goods are handed over for examination.

GOODS MARKED WITH AN ECCN NUMBER (EAR99)

"These items are controlled by the U.S.- Government and authorized for export only to the country of ultimate destination for use by the ultimate consignee or end-user(s). They may not be resold, transferred, or otherwise disposed of, to any other country or to any person other than the authorized ultimate consignee or end-user(s), either in their original form or after being incorporated into other items, without first obtaining approval from the US Government or as otherwise authorized by U.S. law and regulations."

EMBARGOS

Goods subject to certain trade restrictions (statutory requirements, supplier restrictions, etc.) shall be monitored on behalf of export control authorities via information about the participating partners. If this information is not available in the order communication between SINGULUS TECHNOLOGIES AG and the customer at the time of the review, the customer is obliged to additionally ensure compliance with existing trade restrictions. Further information, of any kind, on SINGULUS' behalf shall not be the subject of the respective order.

LEGEND

EU Export List	= AL classification or NLR
Export Classification Number	= ECCN or EAR99, only if the goods are subject to US regulations
Statistical Goods Number	= Information on the classification according to the international HS Code and European regulations
No license required	= NLR / depending on end-use; End-user's country, end user and stakeholders

FURTHER REGULATIONS

Goods of US commercial origin, US storage or goods of US affiliated companies may carry a licensing obligation of the US authorities. Potential US regulatory requirements shall be considered.
