The Issuer processes such data solely for the purposes of implementing the contracts related to the Bond (Art. 6 (1) lit. b GDPR) and meeting legal obligations (e.g., under the German Act on Notes (*Schuldverschreibungsgesetz - SchVG*)). We store your data as long as applicable law (tax code and German Act on Notes) requires us to do so. Link Market Services GmbH receives your data mentioned above on the Issuer's behalf and may forward it to the Issuer as well as other service providers, attorneys and accountants, who assist the Issuer with organizing the approaching vote. Responsibility for processing your personal data lies with the Issuer.
